Once we have received your signed application please allow four to six weeks for processing. We will let you know when your account has been approved for credit.

## CREDIT POLICY

- Accounts are NET 30 DAY terms with approved credit. A 1.5% per month charge will be applied to past due invoices.
- Minimum \$1000 first-time order to establish credit. No minimums apply on reorders.
- Minimum \$300 for new account that is prepaid. Credit cards or checks are approved methods of payment. No minimums apply on reorders.
- An American Traders credit application must be completed and signed before credit can be approved.
- Credit terms do not apply to delinquent accounts.

American Traders has a policy that all accounts 30 days past due will be forwarded to a collection service. All costs incurred with the collection of the outstanding account will be added to the overdue amount.
